On May 18, 2019 a total of 8,333,334 Warrants with an exercise price of \$0.15 per common share of the Corporation (“**Share**”) held by 2176423 Ontario expired. 2176423 Ontario is beneficially owned by Mr. Eric Sprott. This resulted in Mr. Sprott’s beneficial ownership of the Corporation decreasing by approximately 5.3% on a partially diluted basis.

The 8,333,334 Warrants that expired represents a decrease in holdings of approximately 5.3% of the Shares outstanding on a partially diluted basis assuming the Warrants had been exercised.

Prior to the expiry of Warrants, Mr. Sprott beneficially owned and controlled 35,333,334 Shares and 10,333,334 Warrants, representing approximately 26.2% of the outstanding Shares on a non-diluted basis and approximately 31.5% on a partially diluted basis assuming exercise of the Warrants.

Mr. Sprott now beneficially owns and controls 35,333,334 Shares and 2,000,000 Warrants, representing approximately 26.2% of the outstanding Shares on a non-diluted basis and approximately 27.3% on a partially diluted basis assuming exercise of the Warrants.

The Warrants expired unexercised and out of the money. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
