The requirement to file this report was triggered as a result of the acquisition of a \$250,000 principal amount of secured convertible debenture of the Issuer (the “Convertible Debenture”) on June 30, 2019, and market transactions during the month of August 2019. Each \$0.15 principal amount of Convertible Debenture is convertible at the option of the holder into one unit comprised of one common share and one common share purchase warrant.

Since the Offeror's last report in respect of the Issuer dated June 3, 2019 under Part 4 of NI 62-103, there has been a net increase of 422,500 common shares and a net increase of \$250,000 principal amount of Convertible Debenture of the Issuer which the Offeror and any joint actor have beneficial ownership of or exercise control or direction over, representing a net increase of approximately 3.39% of the issued and outstanding common shares of the Issuer, assuming the full conversion of the Convertible Debenture, the exercise of all common share purchase warrants issuable on conversion of the Convertible Debenture and the exercise of all common share purchase warrants which the Offeror and any joint actor have beneficial ownership of or exercise control or direction over.
