The requirement to file this report was triggered on June 30, 2023 as a result of purchase of 2,500,000 units of the Issuer pursuant to a private placement of the Issuer which closed on June 28, 2023, with each such unit comprised of one Common Share and one common share purchase warrant (each, a “Warrant”) of the Issuer and the issuance of 200,000 finders’ warrants of the Issuer to the Offeror as a result of the Offeror acting as an eligible finder in connection with such private placement.

**2.3 State the name of any joint actors.**

AlphaNorth Partners Fund Inc. (“Partners”), Value Preservation Fund Inc. (“Value”) and Steven Palmer (the President and CEO of the Offeror).

Since the last report filed by the Offeror relating to the securities of the Issuer dated July 12, 2021 (the “Last Report”), there has been a net increase of 2,500,000 Common Shares and a net increase of 2,700,000 Warrants which the Offeror and any joint actor have beneficial ownership of or exercise control or direction over, representing a net increase of approximately 2.1% of the Common Shares held by the Offeror and any joint actor since the Last Report, assuming the full exercise of all common share purchase warrants which the Offeror and any joint actor have beneficial ownership of or exercise control or direction over.

Except as otherwise indicated, all amounts in this report are reported as at June 30, 2021.
