On December 11, 2018, the Company acquired beneficial ownership of 100,000 Common Shares of the Issuer at Cdn. \$3.50 per share for an aggregate consideration of \$350,000 (the “Transaction”). The Company now has beneficial ownership of 1,051,000 Common Shares, representing 21.99% of the outstanding Common Shares of the Issuer

Prior to the Transaction, the Company held 951,000 Common Shares, representing 19.90% of the outstanding Common Shares.
