This report relates to the purchase of 5,582,000 common shares (“**AirIQ Shares**”) of AirIQ Inc. (“**AirIQ**”) by Vecima Networks Inc. (“**Vecima**”) from Donald Gibbs and 2204671 Ontario Inc. (the “**Vendors**”). As consideration for the AirIQ Shares, Vecima issued an aggregate of 96,443 common shares of Vecima, at a deemed value of \$948,940, to the Vendors. The deemed consideration per AirIQ Share is \$0.17.

The Common Shares were acquired by Vecima way of arm’s length agreement with the Vendors. AirIQ’s common shares are traded on the TSX Venture Exchange.

On October 24, 2017, Vecima acquired 5,582,000 AirIQ Shares from the Vendors.
