Further to the press release issued by the Issuer on December 19, 2024 on December 19, 2024, the Acquiror entered into a share purchase agreement (the “**Nussir SPA**”) with, amongst others, the Issuer, pursuant to which it agreed to sell its ordinary shares of Nussir ASA (“**Nussir**”) to the Issuer, in exchange for the issuance by the Issuer to the Acquiror of an aggregate of 82,922,061 common shares of the Issuer.

Upon closing of the Nussir SPA, the Acquiror will own and control 82,922,061 common shares of the Issuer. Prior to signing the Nussir SPA, the Acquiror owned no common shares of the Issuer. Upon closing of the Nussir SPA and assuming that the Issuer raises C\$30,000,093 in a concurrent fundraising being completed by the Issuer, the Acquiror will

own 17.8% of the issued and outstanding shares of the Issuer, representing an increase of 17.8%.

The value of the Issuer's common shares being issued to the Acquiror upon closing of the Nussir SPA is C\$24,861,618.30, with each common share of the Issuer having a value of C\$0.30 (which is the equivalent of NOK4.25 per Nussir Share to be purchased by the Issuer, using the exchange rate agreed in the Nussir SPA of NOK1:C\$0.1253388).
