On April 23, 2024, Jupiter participated in the private placement of units of the Issuer (“**Units**”) and acquired 2,234,886 Units at a price of CAD\$0.60 per Unit. Each Unit is comprised of one Share and one-half of one non-transferable common share purchase warrant (“**April Warrant**”), with each whole April Warrant entitling the holder thereof to acquire an additional Share at a price of CAD\$0.80 until April 23, 2025.

representing approximately 13.81% of the Issuer’s 69,715,112 outstanding Shares as reported in its news release dated April 23, 2024, calculated on a partially diluted basis.
