This report relates to the common shares of Inomin Mines Inc. (“Inomin”). Inomin’s head office is located at Suite 1130 – 400 Burrard Street, Vancouver, British Columbia V6C 3A6.

The common shares of Inomin trades on the TSX Venture Exchange under the symbol ‘MINE’. The transaction occurred in British Columbia.

On February 2, 2017, the Acquiror acquired an aggregate of 2,750,000 common shares of Inomin at a deemed price of \$0.07, as consideration for the sale of a mining property to Inomin. As a result of this transaction, the Acquiror currently owns 2,820,000 common shares of Inomin representing 18.17% of the issued and outstanding common shares of Inomin.
