As a result of net purchases of common shares of the Issuer (“**Common Shares**”) acquired by Crescat in September 2023, Crescat’s holdings in the Issuer have risen above 17.5%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

There has been a net increase of 1,682,000 Common Shares in Crescat's holdings representing an increase of approximately 2.78% on a non-diluted basis and, assuming that all of the share purchase warrants of the Issuer ("**Warrants**") held by Crescat are exercised, an increase of approximately 2.39% on a partially diluted basis.

As at September 30, 2023, Crescat exercised control over 6,682,000 Common Shares, representing approximately 13.54% of the outstanding Common Shares, and 2,500,000 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 9,182,000 Common Shares representing approximately 17.7% of the issued Common Shares on a partially diluted basis as at September 30, 2023.
