On October 16, 2017, 2176423 Ontario purchased (the “**Acquisition**”) 5,000,000 Shares of the Corporation at a price of \$0.27 per Share pursuant to a share purchase and sale agreement with an investor. 2176423 Ontario Ltd. is beneficially owned by Eric Sprott. These Shares, together with the 2,000,000 Shares previously acquired by 2176423 Ontario since June 15, 2017 being the date of its last early warning report, represent approximately 2.2% of the outstanding Shares.

The 5,000,000 Shares represent approximately 1.5% of the outstanding Shares. Prior to the date hereof, Mr. Sprott beneficially owned 66,300,596 Shares of the Corporation or approximately 20.4% of the issued and outstanding shares.

Mr. Sprott acquired beneficial ownership of the Shares. See item 2.2.

After giving effect to the Acquisition, Mr. Sprott will beneficially own and control 71,300,596 Shares, representing approximately 21.9% of the outstanding Shares.

The Shares were acquired for investment purposes. Mr. Sprott, through 2176423 Ontario, has a long-term view of the investment and may acquire additional securities either on the open market or through private acquisitions or sell the securities either on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
