On June 15, 2017, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 4,545,455 Shares of the Corporation at a price of \$0.44 per Share. The Shares were purchased from the Corporation pursuant to a private placement. 2176423 Ontario Ltd. is beneficially owned by Eric Sprott.

The 4,545,455 Shares represent approximately 1.4% of the outstanding Shares. Prior to the date hereof, Mr. Sprott beneficially owned 59,755,141 Shares of the Corporation or approximately 19.5% of the issued and outstanding shares.

The Shares were acquired for investment purposes. Mr. Sprott, through 2176423 Ontario, has a long-term view of the investment and may acquire additional securities either on the open market or through private acquisitions or sell the securities either on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.

Item 6 – Agreements, Arrangements, Commitments or Understandings With Respect to Securities of the Reporting Issuer
