Oxy Capital is an organization established under the laws of Portugal. Oxy Capital is an alternative asset management firm founded in 2011, with headquarters in Lisbon, Portugal. The firm invests across various business sectors, focusing on private equity, mezzanine debt, restructuring, and public market opportunities.

2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

On August 8, 2025, Oxy Capital disposed of 1,289,373 Common Shares through the facilities of the TSXV, representing approximately 15.4% of the Common Shares, at an average price of approximately C\$0.23 per Common Share, for aggregate gross proceeds of C\$301,107.08 (the “**Triggering Transaction**”). In Oxy Capital’s last early warning report filed on April 9, 2025, Oxy Capital reported that it had ownership and control of a total of 7,735,741 Common Shares, representing approximately 15.4% of the outstanding

Common Shares. On May 5, 2025, Montero effected a six-for-one consolidation of its Common Shares, as a result of which Oxy Capital's holding was reduced to 1,289,373 Common Shares on a post-consolidation basis. Following the Triggering Transaction, Oxy Capital does not hold any Common Shares.

However, Oxy Capital may from time to time re-evaluate its position and, depending on market conditions,

general economic and industry conditions, and Montero's business, financial condition and prospects, may in the future acquire securities of Montero.
