Waratah is a registered investment adviser under the *Investment Advisers Act of 1940* of the United States that provides investment management services to Waratah Electrification and Decarbonization Fund (“**E&D**”) and Li Equities Investments LP (“**Equities LP**”, and together with E&D, the “**Investors**”).

2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

As at October 31, 2023, Waratah had decreased its holdings of the Issuer's Shares on a partially diluted basis to approximately 13.49% of the issued and outstanding Shares from its holdings on September 30, 2023 of approximately 18.54%.

2.3 State the name of any joint actors.

E&D and Equities LP may be considered joint actors of Waratah.

2.4 State that the eligible institutional investor is eligible to file reports under Part 4 in respect of the reporting issuer.

Waratah is eligible to file reports under Part 4 of National Instrument 62-103 *The Early Warning System and Related Take-Over Bid and Insider Reporting Issues* in respect of the Issuer.

Item 3 – Interest in Securities of the Reporting Issuer

As at September 30, 2023, the date of Waratah's last report, Waratah had control or direction over 10,243,813 Shares, of which E&D beneficially owned 8,421,318 Shares, and Equities LP beneficially owned 1,822,495 Shares, representing an aggregate securityholding percentage of approximately 11.52% assuming 88,907,611 issued and outstanding Shares. E&D and Equities LP also had the right to invest an additional US \$7 million and US \$1.5 million, respectively, if and when, and for the 30 calendar days after, the Shares reach a price of C\$1.50 per Share (each a "**Subsequent Offering Right**"), provided that the exercise of the Subsequent Offering Right is subject to each of E&D, Equities LP, and their joint actors not acquiring, in aggregate, more than 19.99% of the outstanding Shares. By virtue of the Subsequent Offering Right, the Investors were deemed to have beneficial ownership of an additional 7,661,333 Shares, which, with the holdings above, represents an aggregate security holding percentage of 18.54% on a partially diluted basis. The Filer notes that this paragraph corrects certain calculation errors in the Previous Filing.

As at October 31, 2023, Waratah had control or direction over 5,190,313 Shares, of which E&D beneficially owned 4,266,896 Shares, and Equities LP owned 923,417 Shares, representing a securityholding percentage of 5.84% assuming 88,907,611 issued and outstanding Shares. By virtue of the Subsequent Offering Right, the Investors were deemed to have beneficial ownership of an additional 7,860,233 Shares, which, with the holdings above, represents an aggregate securityholding percentage of 13.49% on a partially diluted basis.
