NOTICE IS HEREBY GIVEN that the Annual General and Special Meeting (the "**Meeting**") of Noram Lithium Corp. 1. To receive and consider the financial statements of the Company, together with the auditor's report thereon, for the fiscal year ended January 31, 2024 and January 31, 2025;
2. To set the number of directors at five (5);
3. To elect directors to hold office until the next Annual General Meeting;
4. To re-appoint Dale Matheson Carr-Hilton Labonte LLP, Chartered Professional Accountants and authorize the directors to fix the auditor's remuneration;
5. To consider and, if deemed appropriate, to pass, with or without variation, an ordinary resolution approving and ratifying the Company's security-based compensation plan, as more particularly described in the attached Information Circular; and
6. To transact such other business as may properly come before the Meeting or any adjournments thereof.

**Attendance at the Meeting**

The Company asks that only registered shareholders or their proxies attend the Meeting in person. However, the Company strongly recommends that shareholders vote by Proxy or VIF in advance to ease the voting tabulation at the Meeting by Endeavor Trust Corporation.

Shareholders who are unable to attend the Meeting are requested to complete sign, date and return the enclosed form of proxy indicating your voting instructions. A proxy will not be valid unless it is deposited at the office of Endeavor Trust Corporation, 702-777 Hornby Street, Vancouver, BC V6Z 1S4, Canada, not less than 48 hours (excluding Saturdays, Sundays and holidays) before the time fixed for the Meeting or any adjournments thereof.
