Since February 28, 2021 (the date of Burgundy's last report), Burgundy's holding of common shares of the Reporting Issuer has increased by 1,062,769 shares. The shares outstanding have increased by 7,538,000 since the previous report. This has caused Burgundy's holdings to decrease by 0.1764% of the outstanding shares since the last report filed by Burgundy.
