**Alan C. Savage Exercises Warrant of Innovotech Inc.**

**VANCOUVER, BC, December 27, 2017** – Alan C. Savage acquired beneficial ownership of 2,500,000 common shares of Innovotech Inc. (the “**Issuer**”) on the exercise of share purchase warrants (“**Warrants**”) of the Issuer at an exercise price of \$0.10 per Warrant through Lonsdale Capital Corporation (“**Lonsdale Capital**”) a British Columbia company wholly-owned and controlled by Mr. Savage. The securities were acquired by Mr. Savage through Lonsdale Capital for investment purposes only. Mr. Savage may acquire additional securities of the Issuer in the future.

Mr. Savage now holds beneficial ownership, direction or control over, an aggregate of 9,155,500 common shares, representing approximately 25% of the outstanding common shares of the Issuer.
