As a result of net purchases of common shares of the Issuer (“**Common Shares**”) acquired by Crescat in July 2023, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have risen above 10%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

There has been a net increase of 2,499,953 Common Shares in Crescat’s holdings representing an increase of approximately 3.05% on a non-diluted basis and, assuming that all of the share purchase warrants of the Issuer (“**Warrants**”) held by Crescat are exercised, an increase of approximately 3.01% on a partially diluted basis.

As at July 31, 2023, Crescat exercised control over 8,420,174 Common Shares, representing approximately 10.38% of the outstanding Common Shares, and 1,041,666 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 9,461,840 Common Shares representing approximately 11.51% of the issued Common Shares on a partially diluted basis as at July 31, 2023.

As at July 31, 2023, Crescat and the Joint Actors collectively exercised ownership and control over a total of 8,537,674 Common Shares (representing approximately 10.52% of the outstanding Common Shares) and 1,041,666 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 9,579,340 Common Shares representing approximately 11.66% of the outstanding Common Shares on a partially diluted basis as at July 31, 2023.
