2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

The requirement to file this report was triggered by the closing of the Private Placement on July 26, 2024, in which Crescat, acquired 6,666,667 units of the Issuer (the “**Units**”) at a price of \$0.15 per Unit. Each Unit was comprised of one common share of the Issuer (each, a “**Common Share**”) and one common share purchase warrant of the Issuer (each, a “**Warrant**”). Each Warrant entitles the holder thereof to acquire one Common Share at a price of \$0.23 per Common Share for a term of three years. As a result of the Private Placement, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have risen above 17.50%.

2.3 State the name of any joint actors.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

There has been a net increase in Crescat’s holdings of 6,655,758 Common Shares and 6,666,667 Warrants representing an increase of approximately 3.94% on a non-diluted basis and, assuming that all of the Warrants held by Crescat are exercised, an increase of approximately 4.86% on a partially diluted basis.

As at July 31, 2024, Crescat exercised control over 18,439,342 Common Shares, representing approximately 13.85% of the outstanding Common Shares, and 8,333,333 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 26,772,675 Common Shares representing approximately 18.92% of the issued Common Shares on a partially diluted basis as at July 31, 2024.

As at July 31, 2024, Crescat and the Joint Actors collectively exercised ownership and control over a total of 18,556,842 Common Shares (representing

approximately 13.94% of the outstanding Common Shares) and 8,333,333 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 26,890,175 Common Shares representing approximately 19% of the outstanding Common Shares on a partially diluted basis as at July 31, 2024.
