**Management's Discussion and Analysis (MD&A) Form 51-102F1**

**Overview**

The following management's discussion and analysis ("MD&A") of the financial condition and results of the operations of Tajiri Resources Corp. (the "Company" or "Tajiri") constitutes management's review of the factors that affected the Company's financial and operating performance for the year ended April 30, 2024. This MD&A was written to comply with the requirements of National Instrument 51-102 – Continuous Disclosure Obligations. This discussion is dated August 28, 2024. This MD&A should be read in conjunction with the audited annual consolidated financial statements of the Company for the year ended April 30, 2024, together with the notes. Results are reported in Canadian dollars, unless otherwise noted. The audited annual consolidated financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRS"). Information contained herein is presented as at August 28, 2024, unless otherwise indicated.

Tajiri Resources Corp. was incorporated under the Company Act (British Columbia). The Company was a Capital Pool Company ("CPC") as defined in Policy 2.4 of the TSX Venture Exchange ("Exchange") and completed its qualifying transaction in accordance with Policy 2.4 of the Exchange on April 26, 2011. The Company changed its name on April 26, 2011 to Tajiri Resources Corp. The Company is an exploration stage public company and is listed on the TSX Venture Exchange. The Company's principal business activities include acquiring and developing mineral properties.

The Company is currently engaged in the exploration and development of mineral properties and does not have any source of revenue or operating assets. The recoverability of the amounts shown for mineral properties is dependent upon the ability of the Company to obtain necessary financing to complete exploration, technical studies and, if warranted, development and future profitable production or proceeds from the disposition of properties. The amounts shown as mineral properties represent costs to date and do not necessarily represent present or future values.

At April 30, 2024, the Company had not yet achieved profitable operations, had a working capital deficiency of \$1,096,874 which may not be sufficient to sustain operations over the next year, and expects to incur further losses in the development of its business, all of which casts significant doubt about the Company's ability to continue as a going concern. While the Company has been successful in securing financings in the past, there is no assurance that it will be able to do so in the future.

The Company is a reporting issuer under applicable securities legislation in the provinces of Alberta and British Columbia and its outstanding common shares ("Common Shares") are listed on the Exchange under the symbol "TAJ".

### **Company business**

The Company is exploring its optioned mineral properties and has not yet determined the existence of economically recoverable reserves and does not have any source of revenue or operating assets. The Company was a Capital Pool Company (“CPC”) as defined in Policy 2.4 of the Exchange and completed its qualifying transaction in accordance with Policy 2.4 of the Exchange on April 26, 2011. The Company changed its name on April 26, 2011 to Tajiri Resources Corp. The Company is an exploration stage public company and is listed on the Exchange. The Company’s principal business activities include acquiring and developing mineral properties. During the period the Company conducted minimal exploration work in an effort to

preserve capital. Due to the overall negative financial environment and limited availability of exploration capital the Company has continued to seek out strategic transactions and business opportunities that will be to the benefit of all stakeholders.

### **Mineral properties**

The Company’s principal business activities include acquiring and developing mineral properties. Although the Company has taken steps to verify title to mineral properties in which it has an interest, these procedures do not guarantee the Company’s title. Such properties may be subject to prior agreements or transfers and title may be affected by undetected defects.

At April 30, 2024, the Company’s principal mineral interests are located in Burkina Faso, as follows:

#### **Reo Gold Project, Burkina Faso**

In February 2018 (and modified in May 2018), the Company signed a heads of agreement with Middle Island Resources Ltd. (“MDI”) to enter into the option to acquire a 100% interest in 7 exploration licences located in Burkina Faso called the Reo Gold Project. The Company made USD \$35,000 cash payments to MDI for an exclusivity period of three months in regards to the heads of agreement. The option was exercised prior to the expiry of the exclusivity as such the terms of the option agreement are as follows:

The Vendor will retain a 2% Net Smelter Return (“NSR”) royalty. The company has the right to buy back the entire royalty by paying USD \$5,000,000.

The Company earned its 100% interest in the Reo Gold Project following the payment of \$150,000 made to Middle Island Resources on August 26, 2019.

During the year ended April 30, 2021, five of the seven exploration licenses expired and the Company reapplied for all five. It has now been issued with four new exploration licenses with the fifth (the last to expire) license pending renewal. While the company has no reason to believe that the fifth license will not be reissued it cannot guarantee that such will be the case.

During the year ended April 30, 2022, the sixth license expired May 4, 2021 and the Company applied for new tenure on May 5, 2021. While the company has no reason to believe that the sixth licence will not be reissued it cannot guarantee that such will be the case. On July 21, 2020, the Company agreed that ABC Mining SARL (“ABC”) will hold renewed tenure and rights to any applications for tenure granted in the Reo Gold Project in bare trust for the Company. The Company agreed to pay ABC by issuing 1,000,000 shares and \$25,200 for providing corporate services to the beneficiary. At any time, the Company may acquire all shares of ABC or direct ABC to transfer tenure to the Company or its Nominee.

In the prior periods the Company conducted Reverse Circulation drilling at the Morely Prospect and auger drilling at the K4-K5 Prospect. Results and progress were advised on September 21, 2020, December 7, 2020 and January 26, 2021.

At Morley the Company conducted a drilling program of 23 holes for a total of approximately 2,000 metres (1,995m). Results were reported December 7, 2020 and better intersections included 11m @ 8.6g/t Au

including 3m @ 30.9g/t Au, 13m @ 1.9g/t Au, including 1m @18.0g/t Au; 17m @ 1.6g/t Au including 2m @ 11,2g/t Au and 2m @ 11.8g/t Au.

Drilling at Morley led to a better understanding of the structural controls of the deposit which is hosted entirely within a syntectonic granitoid. Good potential for gold mineralisation, in areas hitherto untested due to cover, were indicated along strike from Morley where the structures that host gold mineralisation at Morley intersect the granite-greenstone contact.

At the K4-K5 prospect, where historic wide spaced auger, RAB, Aircore, RC and diamond drilling had demonstrated gold mineralisation over an area of 14 x 6km, auger drilling to extend and infill historic auger drilling was conducted between December 2020 and May 2021. A total of 1,530 auger holes were drilled for a total of 18,648 metres. Auger holes were drilled vertically by hollow stem power auger to the top of saprolite and the first of metre of saprolite was sampled and assayed by for gold by fire assay at SGS Ouagadougou and for a multielement suite by XRF. The K4-K5 prospect is variably covered by transported laterites and depth of auger holes varied between 3 and 30 metres.

After receipt of the invitation to pay for the renewal of the Dassa Sud Ouest permit was received September 22, 2022, results of the Company's 2021-2022 saprolite auger drilling programs at the K4-5 prospect were announced on October 26, 2022, March 07, 2023 and April 18, 2023.

Results of auger drilling, detailed in the aforementioned announcements, outlined several extensive areas of >100ppb (1,531,700 m<sup>2</sup>) & >250ppb (462,700m<sup>2</sup>) in situ Au anomalism with peak value of 9.2g/t Au, and the scale and tenor of these anomalies is comparable to and considerably larger than those reported by other companies overlying other large West African gold such as Banken NE, Sanbrado, Kiaka, and Namdini.

In addition to the results of auger drilling an extensive re-interpretation of the geology and form of mineralization was conducted through reprocessing of airborne and ground magnetic data, generation of new lithological maps through the use of multielement geochemistry, satellite imagery, inversion of IP data and form mapping of artisanal workings. The reinterpretation of geology has led the company to interpret K4-5 to be a large poly-fold hosted gold deposit, an unusual deposit style, but one which tends to be associated with very large to giant gold deposits globally and is represented in West Africa by only one other known deposit, Wassa which hosts and endowment of ~ 13Moz @ 3.2 g/t (Reference: *Wassa Gold Mine NI-43-101 Technical Report March 2021* (Measured+Indicated = 3.537Moz; Indicated = 8.183Moz) Past production ~ 2.197Moz).

In 2023 & 2024 the Company conducted further reprocessing of airborne and ground magnetic surveys along with additional lithological studies based on XRF derived Multielement geochemistry applied to RAB and RC drill samples. This work resulted in the recognition of a folded graphitic shale whose contacts carry high grade gold mineralization as documented in the Press release of 21<sup>st</sup> of August 2024. The recognition of folded mineralization is an important confirmation of the poly-folded model of mineralization at the K4-5 Prospect.

On the 18<sup>th</sup> July 2024 the Company announced that it had entered into an agreement, pending share holder approval, to acquire a 65% interest in the Yono Property Guyana. Yono is situated within 170 metres of substantial NI 43-101 compliant resources held by G2 Goldfields limited and G Mining Ventures.

On 23<sup>rd</sup> July 2024 the Company released results of reconnaissance sampling at Yono, where high grades (up to 800 g/t Au) from grab samples of quartz float was returned from the north east corner of the Yono Property and lower grade channel samples (0.4 -1.2g/t Au) was returned from channel samples of colluvial material which had previously been exploited by artisanal miners.

### Summary of quarterly results

The Company is an exploration stage entity engaged in the acquisition, exploration, evaluation and development of principally gold resource properties. At this time, any issues of seasonality or commodity market fluctuations have no direct impact on the Company's results or operations. The Company currently defers its exploration expenditures to mineral exploration properties. A summary of selected information for each of the eight most recent quarters is as follows:

### Results of Operations

#### ***Three months ended April 30, 2024, compared with three months ended April 30, 2023:***

The Company's operating loss totaled \$164,752 for the three months ended April 30, 2024, which compares with an operating loss of \$173,866 for the three months ended April 30, 2023. The decrease in loss of \$9,114 was principally due to:

- Foreign exchange gain decreased by \$45,579;
- General exploration decreased by \$131,285;
- Shareholder information, transfer agent, filing fees increased by \$48,049; and
- Professional fee increased by \$12,000.

***Year ended April 30, 2023, compared with year ended April 30, 2022:***

The Company's operating loss totaled \$173,866 for the three months ended April 30, 2023, which compares with an operating loss of \$3,029,997 for the three months ended April 30, 2022. The decrease in loss of \$2,856,131 was principally due to:

- Consulting fees decreased by \$4,512;
- Transfer agent fees decreased by \$3,858;
- Write-off of exploration and evaluation assets decreased by \$2,923,380; and
- Foreign exchange increased by \$66,047.

**Liquidity and capital resources**

The Company has no operating revenue and therefore must utilize its current cash reserves and rely on external financing to generate capital to maintain its capacity to meet working capital requirements. As a result, the Company continues to incur net losses.

The Company reported a working capital deficiency of 1,096,874 at April 30, 2024. The Company has 8,950,000 incentive stock options, and had 37,283,533 share purchase warrants outstanding at April 30, 2024.

During the year ended April 30, 2024, the Company incurred \$43,761 in operating activities, \$92,950 in investing activities relating to expenditures on exploration and evaluations, and generated \$148,750 from financing activities relating to the issuance of common shares. The Company's management believes that the Company has sufficient funds for the next six months to enable to meet the ongoing obligations as they become due. The Company recognizes that it will require additional funding which the Company will raise through the market and debt instruments but there can be no assurance the management can raise the required capital.

To the date of this MD&A, the cash resources of the Company are held in cash with a major Canadian financial institution. The Company continues to have no debt and its credit and interest rate risk is minimal. Accounts payable and accrued liabilities are short-term and non-interest bearing. The Company's liquidity risk with financial instruments is minimal. In addition, accounts receivable is composed mainly of sales tax receivable from government authorities in Canada.

### **Share capital**

- a. The Company incurred \$168,000 (2023 - \$168,000) in management fees to its President and \$118,800 (2023 - \$72,000) in professional fees to its CFO;
- b. The Company incurred \$161,864 (2023 - \$159,878) in exploration expenditures to a director and a private company controlled by a director of the Company.

### **Off-Balance sheet arrangements**

The Company does not have any off-balance sheet items.

### **Significant accounting policies and new accounting policies**

A detailed summary of the Company's significant accounting policies is included in note 2 of the Company's audited consolidated financial statements for the year ended April 30, 2024.

### **Critical accounting estimates**

The Company is a development stage company. The financial statements have been prepared using accounting principles applicable to a going concern which assumes the Company will continue in operation for the foreseeable future and will be able to realize its assets and discharge its liabilities in the normal course of operations. There are conditions which may raise doubt regarding this assumption. The financial statements do not include adjustments that would be necessary should the Company be unable to continue as a going concern. These adjustments could be material.

The amounts recorded for capitalized exploration and evaluation assets, share-based compensation and future income taxes are based on estimates. By their nature, these estimates are subject to measurement uncertainty and changes in these estimates may impact the financial statements for future periods. Amounts recorded for exploration and evaluation assets represent costs incurred to date and are not intended to reflect present or future values. The recoverability of amounts shown for exploration and evaluation assets is dependent upon the discovery of economically recoverable reserves and future production or proceeds from the disposition.

### **Financial instruments**

The Company is exposed in varying degrees to a variety of financial instrument related risks. The Board of Directors approves and monitors the risk management processes, inclusive of documented investment policies, counterparty limits, and controlling and reporting structures. All financial instruments are required to be measured at fair value on initial recognition, except for certain related party transactions.

The Company's exposure to financial risk factors is detailed in Note 12 to the financial statements. While the Company is a development stage company and has no production or sales revenues, it bears commodity price risk in that commodity prices may influence investors and thus impact the outcome of the Company's future equity financings. The Company considers that supply and demand fundamentals for gold remain strong.

### **Capital disclosure**

The Company's objectives when managing capital are to safeguard its ability to continue as a going concern to pursue the development of its mineral properties and to maintain a flexible capital structure which optimizes the cost of capital within a framework of acceptable risk. In the management of capital, the Company includes the components of shareholders' equity.

The Company manages the capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. To maintain or adjust its capital structure, the Company may issue new shares, issue new debt, acquire or dispose of assets or adjust the amount of cash and cash equivalents. As at January 31, 2024, the Company has not entered into any debt financing.

The Company is dependent on the capital markets as its sole source of operating capital and the Company's capital resources are largely determined by the strength of the junior resource markets and by the status of the Company's projects in relation to these markets, and its ability to compete for investor support of its projects.

The Company is not subject to any capital requirements.

### **Investor relations activities**

Investor relations activities of the Company consisted of the dissemination of news releases by officers and directors. In addition, management of the Company responded to requests by shareholders and investment

dealers for information, and disseminated financial information as required by applicable laws. The Directors of the Company have been actively contacting interested parties.

### **Risk factors**

An investment in the securities of the Company is highly speculative and involves numerous and significant risks. Such investment should be undertaken only by investors whose financial resources are sufficient to enable them to assume such risks and who have no need for immediate liquidity in their investment. Prospective investors should carefully consider the risk factors that have affected, and which in the future are reasonably expected to affect, the Company and its financial position. Please refer to the section entitled "Risk Factors" in the Company's management's discussion and analysis for the fiscal year ended April 30, 2024, available on SEDAR+ at [www.sedarplus.ca](http://www.sedarplus.ca). There have been no significant changes to such risk factors since that date.

Risk management is carried out by the Company's management team with guidance from the Audit Committee under policies approved by the Board of Directors. The Board of Directors also provides regular guidance for overall risk management.

### **Disclosure of internal controls**

There have been no significant changes in the Company's disclosure controls and processes.

In the light of the Company's small size, controls and procedures for financial reporting and public disclosure are affected by limited segregation of duties. To mitigate potential control weaknesses, the Chief Executive Officer ('CEO') is actively involved in the day-to-day business of the Company, the CEO and Chief Financial Officer ('CFO') jointly review all payments, and the Company has implemented accounting data review procedures to assist the integrity of reports. It is not economically feasible, at the Company's current size and with the limited number of staff available, to achieve optimum or complete segregation of duties. Also, the Company does not have a sufficient number of finance personnel with the required technical knowledge to address all complex and non-routine accounting transactions that may arise. These weaknesses in internal controls raise the possibility that a material misstatement may not be prevented or detected. Management and the Board of Directors work towards mitigating the risk of material misstatements: the integral role of the CEO in day to day operations provides a direct connection to source data, the review and approval by the Board of all material transactions and the use of accounting data review procedures, all provide a further level of assurance. The Company has no plans to remediate the above weaknesses which are linked with its current size and nature of operations.

Although the British Columbia Securities Commission exempted Venture Issuers from the requirement to certify disclosure controls and procedures, Management has established processes to provide them sufficient knowledge to support representations that they have exercised reasonable diligence that:

- (i) the unaudited interim financial statements do not contain any untrue statement of material fact or omit to state a material fact required to be stated or that is necessary to make a statement not misleading in light of the circumstances under which it is made, as of the date of and for the periods presented by the unaudited interim financial statements; and
- (ii) the unaudited interim financial statements fairly present in all material respects the financial condition, results of operations and cash flows of the Company, as of the date of and for the periods presented.

In contrast to the certificate required for non-venture issuers under National Instrument 52-109 Certification of Disclosure in Issuers' Annual and Interim Filings (NI 52-109), this Venture Issuer Basic Certificate does not

include representations relating to the establishment and maintenance of disclosure controls and procedures (DC&P) and internal control over financial reporting (ICFR), as defined in NI 52-109. In particular, the certifying officers filing this certificate are not making any representations relating to the establishment and maintenance of:

- (i) controls and other procedures designed to provide reasonable assurance that information required to be disclosed by the issuer in its annual filings, interim filings or other reports filed or submitted under securities legislation is recorded, processed, summarized and reported within the time periods specified in securities legislation; and
- (ii) a process to provide reasonable assurance regarding the reliability of financial reporting and the preparation of financial statements for external purposes in accordance with the issuer's GAAP.

The issuer's certifying officers are responsible for ensuring that processes are in place to provide them with sufficient knowledge to support the representations they are making in the certificate.
