The sell transactions took place through the facilities of the Nasdaq Stock Exchange on September 24, 2018. This filing was triggered as EdgePoint Investment Group Inc. sold its entire position of common shares of the Issuer.

The sale of 793,441 common shares took place on September 24, 2018 through the facilities of the Nasdaq Stock Exchange at a sale price of C\$2.42 per share. This resulted in EdgePoint Investment Group Inc. disposing of its entire position in the Issuer (a decrease in ownership from 11.52% to 0%).
