On October 30, 2018 the Issuer completed the Amalgamation with Old Kore. Prior to the Amalgamation, the Acquiror did not hold, directly or indirectly, or have control or direction over, any securities of the Issuer.

Prior to the Amalgamation, the Acquiror held, directly or indirectly, or exercised control or direction over, 6,646,356 common shares of Old Kore which were exchanged for 21,800,485 common shares of the Issuer, representing approximately 30.6% of the issued and outstanding common shares of the Issuer.

As a result of the Amalgamation, the Acquiror acquired control and ownership over an aggregate 21,800,485 common shares of the Issuer.
