On June 30, 2017, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 4,600,000 Shares at a price of \$0.50 per Share. The Shares were purchased from the Corporation pursuant to a bought deal private placement. 2176423 Ontario is beneficially owned by Eric Sprott.

The 4,600,000 Shares represent approximately 2.4% of the issued and outstanding shares.

Mr. Sprott acquired beneficial ownership of the Shares. See item 2.2.

Prior to the Acquisition, Mr. Sprott beneficially owned 14,444,500 Shares representing approximately 8.9% of the then outstanding Shares.

After giving effect to the Acquisition, Mr. Sprott beneficially owns 19,044,500 Common Shares representing approximately 10.0% of the outstanding Shares.

The Shares were acquired for investment purposes. Mr. Sprott, through 2176423 Ontario, has a long-term view of the investment and may acquire additional securities either on the open market or through private acquisitions or sell the securities either on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.

Item 6 – Agreements, Arrangements, Commitments or Understandings With Respect to Securities of the Reporting Issuer
