On December 17, 2025, 2176423 Ontario, a corporation beneficially owned by Eric Sprott, sold 14,868,200 Shares of the Corporation at a price of \$4.00 per Share. The Shares were purchased from the Corporation through a private agreement. 2176423 Ontario is beneficially owned by Eric Sprott. The disposition resulted in (i) Mr. Sprott’s beneficial ownership of the Corporation to decrease by approximately 11.9% on a partially diluted basis since the date of the last early warning report and (ii) Mr. Sprott’s beneficial ownership position to decrease to below 10% on a partially diluted basis.

The 14,868,200 Shares that were sold resulted in a decrease in holdings of approximately 11.9% of the Shares outstanding from what was previously reported in the most recent early warning report. See items 2.2 and 3.4.

Prior to the disposition, Mr. Sprott beneficially owned 14,868,200 Shares and 435,000 share purchase Warrants ("Warrants") representing approximately 10.5% of the outstanding Shares on a non-diluted basis and 10.8% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants.

Mr. Sprott now beneficially owns and/or controls 435,000 Warrants, representing approximately 0.3% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants.

Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
