On May 3, 2023, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 4,000,000 Units of the Corporation at a price of \$0.25 per Unit. Each Warrant entitles the holder thereof to acquire one Share at a price of \$0.35 per Share until two years after the issuance of the Warrant. The Units were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

The 4,000,000 Units combined with prior treasury issuance of Shares by the Corporation, resulted in a decrease of holdings of approximately 6.7% of the outstanding Shares on a partially diluted basis from what was reported in the last early warning report. See item 3.4.

Mr. Sprott acquired beneficial ownership of the Units. See item 2.2.

Prior to the Acquisition, Mr. Sprott beneficially owned or controlled 22,079,796 Shares and 7,439,898 Warrants, representing approximately 12.8% of the outstanding Shares on a non-diluted basis and 16.4% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants.

After giving effect to the Acquisition, Mr. Sprott beneficially owns and controls 26,079,796 Shares and 9,439,898 Warrants, representing approximately 13.2% of the outstanding Shares on a non-diluted basis and 17.1% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants.

The Units were acquired for investment purposes. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
