Item 1 – Security and Reporting Issuer

This report relates to 9,750,000 common shares (the “**Shares**”) of Rochester Resources Ltd. (“**Rochester**” or the “**Company**”) issued at a price of \$0.075 per Share, on exercise of certain outstanding share purchase warrants (the “**Warrants**”), including 5,000,000 Shares issued to the acquiror who is filing this report.

The head office of Rochester is Suite 1305, 1090 West Georgia Street, Vancouver, British Columbia, V6E 3V7.

1.2 State the name of the market in which the transaction or other occurrence that triggered the requirement to file this report took place.

The Shares were acquired from the Company’s treasury pursuant to the exercise of Warrants held by the acquiror.

Eduardo Luna (the “**Acquiror**”) c/o Suite 1305, 1090 W. Georgia Street, Vancouver, BC, V6E 3V7. The Acquiror is the Chairman and a director of the Company.

2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

On February 1, 2022, the Acquiror acquired beneficial ownership of, or control or direction over 5,000,000 Shares, at a price of CND\$0.075 per Share. As a result of this transaction the holding of the Acquiror was increased by more the 2% of the issued and outstanding Shares of Rochester on an undiluted basis.

The acquisition of a total of 5,000,000 Shares of Rochester resulted in the increase of the Acquiror's beneficial ownership of, or control or direction over, the Shares of Rochester from 26.24% to 31.42%. See also Item 3.4.

The Acquiror acquired ownership and control over the Shares.

Immediately before the transaction referred to in Item 2.2 above, the Acquiror held 9,812,636 Shares and 5,000,000 Warrants, representing approximately 26.24% of the then issued and outstanding Shares of Rochester, or 34.94% if all of his Warrants were exercised. Following the issuance of Shares by Rochester totaling 9,750,000, the Acquiror now holds 14,812,636 Shares and no other convertible securities, representing approximately 31.42% of the current issued and outstanding Shares of Rochester.

As a result of the acquisition, the Acquiror's beneficial ownership of, or control or direction over, the Shares increased from 26.24% to 31.42%. As a result of this transaction, the Acquiror acquired securities in an amount equal to 2% or more of the issued and outstanding Shares on an undiluted and a partially diluted basis.
