The requirement to file this report was triggered by the closing of the Private Placement on June 11, 2021, in which Crescat, an investment manager with discretionary authority operating in the United States, acquired 6,666,666 units of the Issuer (the “**Units**”) at a price of \$0.15 per Unit. Each Unit was comprised of one common share of the Issuer (“**Common Shares**”) and one common share purchase warrant of the Issuer (“**Warrants**”). Each Warrant entitles the holder thereof to acquire one Common Share at a price of \$0.25 per Common Share for a term of two years.

2.3 State the name of any joint actors.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

Crescat is eligible to file reports under Part 4 in respect of the Issuer.

As at June 30, 2021, Crescat exercised control over 7,905,929 Common Shares, representing approximately 7.59% of the outstanding Common Shares, and Warrants to purchase 6,666,666 Common Shares. Assuming that the Warrants are exercised, Crescat will hold 14,572,595 Common Shares representing approximately 13.15% of the issued and outstanding Common Shares on a partially diluted basis as at June 30, 2021.

As at June 30, 2021, Crescat and the Joint Actors collectively exercised control over a total of 8,205,929 Common Shares (representing approximately 7.88% of the outstanding Common Shares) and 6,866,666 Warrants. Assuming the Warrants are exercised, Crescat and the Joint Actors will collectively exercise control over an aggregate of 15,072,595 Common Shares representing approximately 13.58% of the outstanding Common Shares on a partially diluted basis as at June 30, 2021.
