On December 9, 2024, 2176423 Ontario, a corporation beneficially owned by Eric Sprott, sold a total of 154,600 Shares of the Corporation at an average price of \$2.434 per Share over the TSX Venture Exchange, resulting in Mr. Sprott’s beneficial ownership of the Corporation to decrease by approximately 2.0% on a partially diluted basis since the date of the last early warning report.

The 154,600 Shares that were sold resulted in a decrease in holdings of approximately 2.0% of the Shares outstanding from what was previously reported in the most recent early warning report. See items 2.2 and 3.4.

Mr. Sprott now beneficially owns 6,357,600 Shares representing approximately 12.4% of the outstanding Shares on a non-diluted basis.

Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Spratt may develop such plans or intentions in the future.
