As a result of the expiration of 4,909,258 Warrants held by Crescat and the Joint Actors (as defined herein) in June, 2023, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have fallen below 17.5%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

As at June 30, 2023, Crescat exercised control over 20,454,566 Common Shares, representing approximately 16.25% of the outstanding Common Shares.
