This report was triggered as a result of purchases that occurred over the TSX Venture Exchange and a private placement subscription (the “**Private Placement**”).

Crescat acquired 875,000 units of the Issuer (the “**Units**”) at a price of \$0.08 per Unit through the Private Placement which closed on June 18, 2024. Each Unit was comprised of one common share of the Issuer (each, a “**Common Share**”) and one Common Share purchase warrant (each, a “**Warrant**”). Each Warrant entitles the holder to acquire one Common Share at a price of \$0.12 per Common Share for a term of one year. As a result of the Private Placement and net purchases of Common Shares by Crescat in June 2024, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have risen above 20%.

2.3 State the name of any joint actors.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

There has been a net increase of 1,867,609 Common Shares and 875,000 Warrants in Crescat’s holdings representing an increase of approximately 0.57% on a non-diluted basis and, assuming that all of the Warrants held by Crescat are exercised, an increase of approximately 1.03% on a partially diluted basis.

As at June 30, 2024, Crescat exercised control over 25,283,041 Common Shares, representing approximately 18.52% of the outstanding Common Shares, and 2,541,667 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 27,824,708 Common Shares representing approximately 20.01% of the issued Common Shares on a partially diluted basis as at June 30, 2024.

As at June 30, 2024, Crescat and the Joint Actors collectively exercised ownership and control over a total of 25,739,541 Common Shares (representing approximately 18.86% of the outstanding Common Shares) and 2,541,667

Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 28,281,208 Common Shares representing approximately 20.34% of the outstanding Common Shares on a partially diluted basis as at June 30, 2024.
