The Issuer’s issued and outstanding share capital increased. As a result, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors have fallen below 10%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

There has been a net increase of 87,278 Common Shares in Crescat's holdings; however, on a percentage basis there has been a decrease of approximately 2.26% due to the increase in the Issuer's issued and outstanding share capital.

As at April 30, 2021, Crescat exercised control over 7,962,062 Common Shares, representing approximately 6.11% of the outstanding Common Shares, and Warrants to purchase 3,749,999 Common Shares. Assuming that the Warrants are exercised, Crescat will hold 11,712,061 Common Shares representing approximately 8.73% of the issued Common Shares on a partially diluted basis.

Assuming the Warrants are exercised, Crescat and the Joint Actors will collectively exercise control over an aggregate of 11,987,061 Common Shares representing approximately 8.93% of the outstanding Common Shares on a partially diluted basis.
