The Issuer’s issued and outstanding share capital increased in November 2023. As a result of the foregoing, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have fallen below 17.5%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

Crescat is eligible to file reports under Part 4 in respect of the Issuer.

There has been a net increase of 2,137,750 Common Shares and a net decrease of 1,750,001 Common Share purchase warrants of the Issuer (“**Warrants**”) in Crescat’s holdings; however, on a percentage basis there has been a decrease of approximately 4.39% of the issued Common Shares on a partially diluted basis due to the increase in the Issuer’s issued and outstanding share capital.

As at November 30, 2023, Crescat exercised control over 33,882,822 Common Shares, representing approximately 16.02% of the outstanding Common Shares, and 2,000,000 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 35,882,822 Common Shares representing approximately 16.80% of the issued Common Shares on a partially diluted basis as at November 30, 2023.

As at November 30, 2023, Crescat and the Joint Actors collectively exercised ownership and control over a total of 34,082,822 Common Shares (representing approximately 16.11% of the outstanding Common Shares) and 2,000,000 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 36,082,822 Common Shares representing approximately 16.90% of the outstanding Common Shares on a partially diluted basis as at November 30, 2023.
