Crescat acquired 1,111,200 previously issued common shares of the Issuer (“**Common Shares**”) and 555,599 previously issued common share purchase warrants of the Issuer (“**Warrants**”) through a private transaction that closed on June 3, 2021.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

Crescat is eligible to file reports under Part 4 in respect of the Issuer.

There has been a net increase of 1,265,895 Common Shares and 555,599 Warrants in Crescat's holdings representing an increase of approximately 0.79% of the Issuer's outstanding Common Shares and, assuming that the Warrants are exercised, an increase of approximately 0.75% on a partially diluted basis.

As at June 30, 2021, Crescat exercised control over 5,977,555 Common Shares, representing approximately 7.67% of the outstanding Common Shares, and Warrants to purchase 4,555,599 Common Shares. Assuming that the Warrants are exercised, Crescat will hold 10,533,154 Common Shares representing approximately 12.76% of the issued Common Shares on a partially diluted basis as at June 30, 2021.

As at June 30, 2021, Crescat and the Joint Actors collectively exercise control over a total of 6,032,555 Common Shares (representing approximately 7.74% of the outstanding Common Shares) and 4,555,599 Warrants. Assuming the Warrants are exercised, Crescat and the Joint Actors will collectively exercise control over an aggregate of 10,588,154 Common Shares representing approximately 12.83% of the outstanding Common Shares on a partially diluted basis as at June 30, 2021.
