The Issuer’s issued and outstanding share capital increased in June 2025. As a result of the foregoing, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have fallen below 15%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, Kevin and Linda Smith Living Trust dtd 7/21/1998, and Kevin and Linda Smith Charitable Trust UAD 08/07/2023 (the “**Joint Actors**”) may be considered joint actors.

There has been a net increase of 2,228,049 common shares of the Issuer (“**Common Shares**”) and 1,000,000 share purchase warrants of the Issuer (“**Warrants**”) in Crescat’s holdings; however, on a percentage basis there has been a decrease of approximately 2.40% on a non-diluted basis and, assuming that all of the Warrants held by Crescat are exercised, a decrease of approximately 2.33% on a partially diluted basis due to the increase in the Issuer’s issued and outstanding share capital.

As at June 30, 2025, Crescat exercised control over 9,764,264 Common Shares, representing approximately 11.01% of the outstanding Common Shares, and 2,731,599 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 12,495,863 Common Shares representing approximately 13.67% of the outstanding Common Shares on a partially diluted basis as at June 30, 2025.

As at June 30, 2025, Crescat and the Joint Actors collectively exercised ownership and control over a total of 9,781,564 Common Shares, representing approximately 11.03% of the outstanding Common Shares, and 2,731,599 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 12,513,163 Common Shares representing approximately 13.69% of the outstanding Common Shares on a partially diluted basis as at June 30, 2025.
