1. this certificate is being delivered pursuant to Sections 2.1 and 4.1 of National Instrument 44-101 – *Short Form Prospectus Distributions* ("**NI 44-101**"), which sections relate to the qualification of the Corporation to file a prospectus in the form of a short form prospectus, and Sections 2.2 and 7.1 of National Instrument 44-102 – *Shelf Distributions*, which sections relate to the qualification of the Corporation to file a preliminary base shelf prospectus;
2. the Corporation satisfies all of the criteria set forth in Section 2.2 of NI 44-101 in order to be qualified to file a prospectus in the form of a short form prospectus in that:
 - (a) the Corporation is an electronic filer under National Instrument 13-101 – *System for Electronic Document Analysis and Retrieval (SEDAR)*;
 - (b) the Corporation is a reporting issuer in at least one jurisdiction of Canada;
 - (c) the Corporation has filed with the securities regulatory authority in each jurisdiction of Canada in which it is a reporting issuer all periodic and timely disclosure documents that it is required to have filed in that jurisdiction:
 - (i) under applicable securities legislation;
 - (ii) pursuant to an order issued by the securities regulatory authority; or
 - (iii) pursuant to an undertaking to the securities regulatory authority;
 - (d) the Corporation has, in at least one jurisdiction of Canada in which it is a reporting issuer:

- (i) current annual financial statements (as such term is defined in NI 44-101); and
 - (ii) a current AIF (as such term is defined in NI 44-101); and
 - (e) the Corporation's equity securities are listed and posted for trading on a short form eligible exchange and the Corporation is not an issuer:
 - (i) whose operations have ceased; or
 - (ii) whose principal asset is cash, cash equivalents, or its exchange listing; and
3. all of the material incorporated by reference in the preliminary short form base shelf prospectus and not previously filed is being filed with the preliminary short form base shelf prospectus.
