2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

On December 4, 2025, 2176423 Ontario acquired (the “Acquisition”) 5,000,000 Units at a price of \$0.60 per Unit. Each Warrant entitles the holder thereof to acquire one Share at a price of \$0.75 per Share until December 4, 2027, The Units were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

The Acquisition, combined with prior and concurrent additional Share issuances by the Corporation, resulted in a decrease in holdings of approximately 6.7% of the outstanding Shares on a partially diluted basis from the date of the last early warning report. See items 2.2 and 3.4

Mr. Sprott acquired beneficial ownership of the Units. See item 2.2.

Prior to the Acquisition, Mr. Sprott beneficially owned 13,958,510 Shares, \$2,000,000 principal amount of convertible debentures and 3,030,000 Warrants, representing approximately 18.0% of the outstanding Shares on an undiluted basis and approximately 29.2% of the outstanding Shares on a partially diluted basis assuming exercise of such Warrants and conversion of all such debentures (for 9,230,138 Shares).

As a result of the Acquisition, Mr. Sprott beneficially owns 18,958,510 Shares, \$2,000,000 principal amount of convertible debentures and 5,530,000 Warrants, representing approximately 14.9% of the outstanding Shares on an undiluted basis and approximately 23.7% of the outstanding Shares on a partially diluted basis assuming exercise of such Warrants and conversion of all such debentures.

The Units were acquired for investment purposes. Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.

Item 6 – Agreements, Arrangements, Commitments or Understandings With Respect to Securities of the Reporting Issuer

2176423 Ontario entered into a voting and support agreement ("**Support Agreement**") with Pan American Silver Corp. ("**Pan American**"), pursuant to which 2176423 Ontario agreed to vote any

securities of the Corporation (“**Corporation Securities**”) held by it in favour of certain matters involving Pan American at any meeting of the Corporation’s securityholders (being “**Galleon Resolutions**”, as further described and defined in the Support Agreement), including the conversion by Pan American of certain Warrants and the conversion of an unsecured convertible debenture in the principal amount of \$8,000,000.

2176423 Ontario has also agreed not to grant any other proxy or voting rights with respect to its Corporation Securities, and not to exercise any rights or remedies available at law that may delay or interfere with the successful completion of the Transactions (as defined in the Support Agreement). The Support Agreement will automatically terminate on the earlier of (i) the approval of the Galleon Resolutions,, (ii) August 31, 2026, and (iii) the termination of the Support Agreement or the agreements in respect of the Transactions.
