On November 6, 2025, the Acquiror purchased an aggregate of 3,695,000 units (the "**Units**") of Palamina at a price of \$0.125 per Unit. Each Unit consists of one common share and one warrant (each a "**Warrant**"), with each Warrant is exercisable to acquire one common share at a price of \$0.20 for a period of two years after the date of issuance. The acquired shares increased the Acquiror's overall holdings in the Reporting Issuer to 16.1% of the outstanding shares of Palamina on an undiluted basis and 20.5% on a partially diluted basis. The Warrants can not be exercised by the Acquiror unless and until all regulatory and shareholder approvals are obtained.

On November 6, 2025, the Acquiror purchased an aggregate of 3,695,000 Units of Palamina at a price of \$0.125 per Unit.

Immediately prior to the purchases, the Acquiror had beneficial ownership, or exercised control or direction, both directly and indirectly over 9,955,802 shares and 975,000 options, representing approximately 13.9% of the outstanding shares of Palamina on an undiluted basis and 15.0% of the outstanding shares of Palamina on a partially diluted basis. Following the purchase, the Acquiror has beneficial ownership or exercises direction or control over, directly and indirectly: (a) 13,651,802 shares; (b) 975,000 Options; and (c) 3,695,000 warrants, representing approximately 16.1% of the outstanding shares of Palamina on an undiluted basis and 20.5% on a partially diluted basis. The warrants can not be exercised by the Acquiror unless and until all regulatory and shareholder approvals are obtained.

The Acquiror acquired an aggregate of 3,695,000 Units of Palamina.
