As a result of net purchases of common shares of the Issuer (“**Common Shares**”) acquired by Crescat in June 2023, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have risen above 17.5%.

Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

There has been a net increase of 2,759,097 Common Shares in Crescat's holdings representing an increase of approximately 0.86% on a non-diluted basis and, assuming that all of the share purchase warrants of the Issuer ("**Warrants**") held by Crescat are exercised, an increase of approximately 0.75% on a partially diluted basis.

As at June 30, 2023, Crescat exercised control over 23,795,384 Common Shares, representing approximately 16.10% of the outstanding Common Shares, and 2,481,424 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 26,276,808 Common Shares representing approximately 17.49% of the issued Common Shares on a partially diluted basis as at June 30, 2023.

As at June 30, 2023, Crescat and the Joint Actors collectively exercised ownership and control over a total of 23,912,822 Common Shares (representing approximately 16.18% of the outstanding Common Shares) and 2,481,424 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 26,394,246 Common Shares representing approximately 17.57% of the outstanding Common Shares on a partially diluted basis as at June 30, 2023.
