The Issuer’s issued and outstanding share capital increased in July 2024. As a result of the foregoing, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have fallen below 20%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

Crescat is eligible to file reports under Part 4 in respect of the Issuer.

There has been a net increase of 2,958,897 common shares of the Issuer (“**Common Shares**”) and 2,016,416 share purchase warrants of the Issuer (“**Warrants**”) in Crescat’s holdings; however, due to an increase in the Issuer’s issued and outstanding share capital, there has been a net decrease of approximately 1.60% in Crescat’s securityholding percentage on a non-diluted basis and, assuming that all of the Warrants held by Crescat are exercised, a net decrease of approximately 1.11% in Crescat’s securityholding percentage on a partially diluted basis.

As at July 31, 2024, Crescat exercised control over 30,988,131 Common Shares, representing approximately 16.80% of the outstanding Common Shares, and 6,569,254 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 37,557,385 Common Shares representing approximately 19.66% of the outstanding Common Shares on a partially diluted basis as at July 31, 2024.

As at July 31, 2024, Crescat and the Joint Actors collectively exercised ownership and control over a total of 31,105,569 Common Shares (representing approximately 16.86% of the outstanding Common Shares) and 6,569,254 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 37,674,823 Common Shares representing approximately 19.72% of the outstanding Common Shares on a partially diluted basis as at July 31, 2024.
