**What are we offering?**

<b>Offering:</b>	Non-brokered private placement of up to 3,000,000 flow-through units of the Company (each, a “ <b>FT Unit</b> ” and collectively, “ <b>FT Units</b> ”) at a price of \$0.75 per FT Unit for gross proceeds of up to \$2,250,000 (the “ <b>Offering</b> ”) on a charity flow-through basis. Each FT Unit will consist of one common share in the capital of the Company (each, a “ <b>FT Share</b> ” and collectively, “ <b>FT Shares</b> ”) and one common share purchase warrant of the Company (each a “ <b>FT Warrant</b> ” and collectively, “ <b>FT Warrants</b> ”). Each FT Warrant will be exercisable to acquire one common share (each a “ <b>Warrant Share</b> ”) at a price of \$0.80 per Warrant Share for a period of 24 months from the Closing Date (as defined below).
<b>Offering Price:</b>	\$0.75 per FT Unit.
<b>Offering Amount:</b>	A maximum amount of 3,000,000 FT Units for maximum gross proceeds of \$2,250,000. There is no minimum amount.

The FT Warrants to be issued pursuant to the Offering will not be listed for trading on any stock exchange.
<b>Closing Price:</b>	The closing price of the Common Shares on the TSXV on October 8, 2025 was \$0.86.

## SUMMARY DESCRIPTION OF BUSINESS

### What is our business?

Future Fuels is a mineral exploration company focused on advancing Canadian mining projects. The Company's current focus is the advancement of its flagship Hornby Project (the "**Hornby Project**"), a 3,407km<sup>2</sup> prospective uranium package located in Nunavut, Canada. The Company also holds the Corvette property, which consists of 65 mineral claims totaling approximately 3,370 ha, located in Quebec's James Bay region, 190 km east of Radisson, QC. ### Recent Developments

On November 14, 2024, the Company announced that it had entered into an asset purchase agreement dated November 13 with IsoEnergy Ltd. to acquire a 100% interest in the Mountain Lake Project—comprising 5,625 hectares in Nunavut—in exchange for common shares and net smelter royalty arrangements. The Company announced a concurrent private placement of up to 12,000,000 units at a price of \$0.25 per unit (the "**Concurrent PP**").

On December 5, 2024, the Company completed the acquisition of six mineral leases in the Hornby Basin, Nunavut Territory totaling approximately 6,201 hectares.

On December 19, 2024, the Company announced that it had closed the first tranche of its Concurrent PP, issuing 9,246,980 units at \$0.25 per unit, each unit comprising one common share and one-half warrant exercisable at \$0.40 for 24 months. This tranche satisfied the financing condition for the Mountain Lake acquisition.

On December 20, 2024, the Company announced it had arranged a new non-brokered flow-through private placement of up to 2,222,222 flow through common shares at \$0.45 per share for gross proceeds of up to CAD 1,000,000, to be used for Canadian exploration expenses (the "**Prior FT PP**").

On December 24, 2024, the Company announced that it had closed its Prior FT PP of 2,222,222 flow through common shares at \$0.45 per share for gross proceeds of CAD 1,000,000.

On January 7, 2025, the Company announced that it had appointed Bernd Christmas and Mark Riccio to its board of directors, accepted the resignation of Kevin Bottomley, and granted 4,380,000 stock options exercisable at \$0.44 for two years until January 7, 2027.

On February 3, 2025, the Company announced that it had entered into an amendment to the Mountain Lake asset purchase agreement, extending the outside acquisition closing date from January 31 to February 14, 2025. The announcement also confirmed that the first tranche of the Concurrent PP had closed—and no second tranche would be issued.

On February 18, 2025, the Company announced that it had completed the acquisition of the Mountain Lake Property in Nunavut, expanding its consolidated land holdings in the Hornby Basin to over 342,064 hectares.

On March 10, 2025, the Company announced that it had engaged MCS Market Communication Service GmbH (“**MCS**”) under a six-month (plus optional extension) marketing services agreement to support investor relations and marketing.

On March 31, 2025, the Company announced that it had initiated an integrated, district-scale exploration strategy across the Hornby Project and provided an update on its investor relations and marketing activities.

On May 30, 2025, the Company announced that it had entered into a partnership with VRIFY Technology Inc. (“**VRIFY**”) to deploy AI and predictive modeling in refining exploration at Hornby Basin. The Company also announced that it had entered into a marketing agreement with Zimtu Capital Corp.

On June 10, 2025, the Company announced that it had identified high-priority conductive EM anomalies at Hornby Basin and provided a subsequent update on its investor relations and marketing progress, including the renewal of its engagement of MCS.

On June 19, 2025, the Company announced that it had received results from a hyperspectral remote sensing survey at its 100%-owned Hornby Project, identifying spectral signatures consistent with uranium alteration systems. This provided further geophysical support for exploration targeting.

On July 17, 2025, the Company announced that it had launched a new non-brokered private placement offering up to 3,750,000 units at \$0.40 per unit (each unit comprising one common share and one-half warrant at \$0.60), aiming to raise up to CAD 1,500,000 (the “**June 2025 PP**”).

On August 21, 2025, the Company announced that it had closed the fully-subscribed June 2025 PP.

On September 5, 2025, the Company announced it had launched the Offering. The Company also provided a subsequent update on its investor relations and marketing progress, including the renewal of its engagement of MCS and its engagement of Rumble Strip Media Inc. to support investor relations for a 35-day term.

On September 22, 2025, the Company announced that it had received the necessary permits to commence exploration on the Hornby Project.

On September 30, 2025, the Company announced that it had commenced mobilization of crews and equipment for its Phase One exploration program at the Hornby Project.

On October 6, 2025, the Company announced the acquisition of high-resolution geophysical data covering the Mountain Lake Property. The Company intends to incorporate the data into Vrifly's DORA AI platform to provide high-resolution geophysical coverage over the Mountain Lake Property with the goal of guiding future exploration and target generation. The Company also announced an increase to the budget of its engagement with MCS pursuant to the terms thereof.

## **Material Facts**

There are no material facts about the securities being distributed that have not been disclosed elsewhere in this Offering Document or in any other document filed by the Company in the 12 months preceding the date of this Offering Document.

The FT Shares and FT Warrants will each be issued as “flow-through shares” within the meaning of the *Income Tax Act* (Canada). Upon the exercise of the FT Warrants, the underlying Common Shares will not be issued as “flow-through shares” within the meaning of the *Income Tax Act* (Canada). The gross proceeds of the Offering will be used to incur “Canadian exploration expenses” that are “flow-through critical mineral mining expenditures”, within the meaning of the *Income Tax Act* (Canada), on the Company’s flagship Hornby Project.

**What are the business objectives that we expect to accomplish using the available funds?**

The Company expects to use the gross proceeds from the Offering to fund exploration of its Hornby Project, or other Canadian mineral resource projects.

The Offering may alleviate the risk that the Company is unable to continue as a going concern, but is unlikely to result in the removal of that notation in the Company's financial statement filings for the foreseeable future.
