NOTICE AND ACCESS NOTIFICATION TO SHAREHOLDERS

ANNUAL GENERAL MEETING TO BE HELD ON SEPTEMBER 14, 2020

You are receiving this notification because Elysee Development Corp. (the “**Company**”) has opted to use the “notice and access” rules for delivery of its information circular (the “**Circular**”) to its shareholders in respect of its annual general meeting to be held on September 14, 2020 (the “**Meeting**”). - **APPROVAL OF FINANCIAL STATEMENTS:** To receive the auditor’s report and the audited financial statements of the Company for the fiscal year ended December 31, 2019

- **FIXING NUMBER OF DIRECTORS:** To fix the number of Directors of the Company at four (4) and electing Directors as nominated by management for the ensuing year
- **RE-APPOINTMENT OF AUDITORS:** To reappoint Davidson & Company LLP as auditors of the Company for the ensuing year and to authorize the directors to fix their remuneration.
- **OTHER BUSINESS:** To transact such other business as may properly come before the Meeting or any adjournment thereof.

SHAREHOLDERS ARE REMINDED TO REVIEW THE CIRCULAR PRIOR TO VOTING.
