2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

Pursuant to an early warning report dated January 17, 2012, Lonmin reported that it then beneficially held, through 6529241 Canada Inc., a wholly-owned subsidiary of Lonmin, an aggregate of 23,957,895 Shares and 6,578,948 Warrants (as defined in such early warning report), which together then constituted approximately 19.8% of the issued and outstanding Shares (assuming the exercise of all of the Warrants, which Warrants expired unexercised effective on December 31, 2012). Subsequently, in June 2012 6529241 Canada Inc. purchased on the Toronto Stock Exchange an additional 85,000 Shares in aggregate, representing less than 2% of the then outstanding Shares. Lonmin understands that the Corporation undertook a series of treasury issues of Shares between the date of such early warning report and May 16, 2017, none of which involved participation by Lonmin. As a result of the aggregate dilution resulting from such treasury issuances, Lonmin’s beneficial ownership interest decreased to below 10% of the outstanding Shares and remained below 10% thereafter.

On September 28, 2018, 6529241 Canada Inc. entered into an agreement to dispose (the “**Disposition**”) of 24,042,895 Shares at a price of \$0.165 per Share, which Disposition closed effective October 12, 2018. Such Shares were purchased by a company pursuant to a share purchase agreement. This report is being filed to update Lonmin’s previously filed early warning report relating to its beneficial holdings of Shares.

Immediately prior to the Disposition, Lonmin beneficially owned 24,042,895 Shares, representing approximately 6.8% of the outstanding Shares on a non-diluted basis.

As a result of the Disposition, Lonmin has ceased to hold any Shares.
