On December 17, 2025, 2176423 Ontario donated 163,306,752 Shares to The Sprott Foundation. 2176423 Ontario is beneficially owned by Eric Sprott and The Sprott Foundation is controlled by Mr. Sprott.

The 163,306,752 Shares that were donated to The Sprott Foundation, along with previous Share issuances by the Corporation resulted in a decrease in holdings of approximately 8.0% of the outstanding Shares on a partially diluted basis from what was reported in the last early warning report.

2176423 Ontario Ltd., disposed of beneficial ownership of, but retained control over, the 163,306,752 Shares. See item 2.2

Prior to the donation, Mr. Sprott beneficially owned and controlled 165,306,752 Shares, representing approximately 13.5% of the outstanding Shares on a non-diluted basis.

As a result of the donation, Mr. Sprott now beneficially owns and controls 2,000,000 Shares, representing approximately 0.2% of the outstanding Shares, but still controls the donated 163,306,752 Shares. Therefore, Mr. Sprott still controls 165,306,752 Shares, representing approximately 13.5% of the issued and outstanding Shares.

Mr. Sprott has a long-term view of the investment and may acquire additional securities of the Corporation including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
