On October 15, 2025, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 11,719,000 Shares of the Corporation at a price of \$1.28 per Shares. The Shares were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

The Acquisition of 11,719,000 Shares, combined with prior issuances of Shares by the Corporation, resulted in an increase of holdings of approximately 5.9% of the outstanding Shares on a partially diluted basis from what was reported in the last early warning report. See item 3.4.

Mr. Sprott acquired beneficial ownership of the Shares. See item 2.2.

Prior to the Acquisition, Mr. Sprott beneficially owned and controlled 10,869,795 Shares and 1,870,500 Warrants, representing approximately 8.7% of the outstanding Shares on a non-diluted basis and 10.1% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants.

Mr. Sprott now beneficially owns and controls 22,588,795 Shares and 1,870,500 Warrants, representing approximately 14.9% of the outstanding Shares on a non-diluted basis and 16.0% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants.

Mr. Sprott currently has no other plans or intentions that relate to, or would result in, the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
