On November 30, 2018, 974052 BC Ltd. exercised 3,569,499 warrants (the “**Warrants**”) at a price of \$0.20 per underlying share. The Warrants were issued pursuant to a subscription agreement entered into between the Issuer and 0974052 BC Ltd., a company wholly owned by the Trust as part of a larger private placement of the Issuer’s securities.

0974052 BC Ltd. and the Charles E. Fipke Alter Ego Trust

Item 3 – Interest in Securities of the Reporting Issuer

3,569,499 shares issued to 0974052 BC Ltd. on November 30, 2018. The Acquiror’s securityholding percentage in the Shares was unchanged at 47.57% assuming exercise of all warrants and options held by the Acquiror. The Acquiror concurrent upon

exercise of the Warrants gifted 25,000 shares to third parties as a result of which the Acquiror's holdings was reduced to 47.37% assuming exercise of all outstanding warrants and stock options of the Acquiror.

3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file this report.

The Acquiror acquired ownership of 3,569,499 shares and exercised 3,569,499 warrants.

The Acquiror held 9,800,969 shares, 160,333 stock options and 3,579,999 warrants of the Issuer prior to the Transaction (47.57% of the outstanding shares of the Issuer assuming exercise of the options and warrants) and the Acquiror held 13,370,468 shares, 10,500 warrants and 160,333 stock options after the Transaction (47.57% of the outstanding shares of the Issuer assuming exercise of the warrants and stock options held by the Acquiror). Immediately following the Transaction the Acquiror gifted 54,500 to third parties as a result of which the Acquiror's holdings became 13,315,968 shares (47.37% assuming exercise of all outstanding warrants and stock options held by the Acquiror).
