On November 9, 2022 Burgundy sold shares of the Reporting Issuer.

Since September 30, 2015 (the date of Burgundy's last report), Burgundy's holding of common shares of the Reporting Issuer has decreased by 811,622 common shares. The shares outstanding have increased 710,000 since the previous report. This has caused Burgundy's holdings to decrease by 3.2879% of the outstanding shares since the last report filed by Burgundy.

3,971,878 shares of the Reporting Issuer, representing 13.9786% of the outstanding shares of the Reporting Issuer.
