On August 5, 2025, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 1,875,000 Units of the Corporation at a price of \$0.80 per Unit. Each Warrant entitles the holder thereof to acquire one Share at a price of \$1.10 per Share until two years after the issuance of the Warrant. The Units were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

The Acquisition of 1,875,000 Units, combined with prior issuances of Shares by the Corporation, resulted in a decrease of holdings of approximately 2.4% of the outstanding Shares on a partially diluted basis from what was reported in the last early warning report. See item 3.4.

Mr. Sprott acquired beneficial ownership of the Units. See item 2.2.

Prior to the Acquisition, Mr. Sprott beneficially owned and controlled 27,954,500 Shares and 13,977,250 Warrants, representing approximately 10.4% of the outstanding Shares on a non-diluted basis and 14.8% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants.

Mr. Sprott now beneficially owns and controls 29,829,500 Shares and 15,852,250 Warrants, representing approximately 10.5% of the outstanding Shares on a non-diluted basis and 15.2% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants.

Mr. Sprott currently has no other plans or intentions that relate to, or would result in, the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
