This report relates to common shares ("Kincora Shares") and free-attaching options ("Kincora Options") of Kincora Copper Limited, ticker "KCC", with an address at Suite #400, 837 West Hastings Street, Vancouver, British Columbia, Canada V6C 3N6.

Brokered placement of Kincora Shares on the ASX (the "Placement").

BBH acquired 10,400,000 Kincora Shares and 5,200,000 free-attaching Kincora Options on August 4, 2023 on closing of the Placement.

On August 4, 2023 BBH acquired 10,400,000 Kincora Shares, increasing BBH's beneficial ownership from an immediately prior 12.9% to a total of 15.4% in the total issued shares of Kincora Copper Limited. In addition, BBH acquired 5,200,000 free-attaching Kincora Options expiring 24 months from date of issue, each convertible into one fully paid Kincora Share on exercise, representing securities convertible into 2.5% of the total issued shares of Kincora Copper Limited.

3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file this report:

BBH acquired ownership and control of the shares in Kincora Copper Limited.

Immediately prior to the transaction that triggered the requirement to file this Report, BBH held 21,515,152 Kincora Shares (equating to a 12.9% interest in the total issued shares of Kincora Copper Limited) and immediately after, held 31,915,152 Kincora Shares (equating to a 15.4% interest in the total issued shares of Kincora Copper Limited following the Placement).

In addition, BBH acquired 5,200,000 free-attaching Kincora Options expiring 24 months from date of issue, each convertible into one fully paid Kincora Share on exercise, representing securities convertible into 2.5% of the total issued shares of Kincora Copper Limited. No Kincora Options were held by BBH prior to the August 4, 2023 Placement.

BBH has ownership and control over 31,915,152 common shares, representing 15.4% of the total issued common shares of Kincora Copper Limited immediately after completion of its most recent acquisition.

In addition, BBH has ownership and control over 5,200,000 free-attaching Kincora Options expiring 24 months from date of issue, each convertible into one fully paid Kincora Share on exercise, representing securities convertible into 2.5% of the total issued shares of Kincora Copper Limited.

(b) the acquiror, either alone or together with any joint actors, has ownership but control is held by persons or companies other than the acquiror or any joint actor:

On March 8, 2023 Luke Murray, Chief Operating Officer of The Bloomfield Group (a group of companies wholly owned by BBH), joined the board of Kincora Copper Limited as a non-executive director.
