On August 26, 2024, the Company entered into a loan agreement with Eagle Putt Ventures Inc., a company controlled by the Acquiror, pursuant to which the Acquiror advanced loans to the Company in the amounts of CAD\$200,000 and USD\$116,752.50 (the “**Transaction**”).

As partial consideration for the transaction, the Company issued 2,233,713 Warrants to the Acquiror. Each Warrant entitles the holder thereof to purchase on Common Share at an exercise price of \$0.16 per Common Share for a period of two years from the date of issuance.

The Acquiror is filing this report pursuant to National Instrument 62-103 – *The Early Warning System and Related Take-Over Bid and Insider Reporting Issues* as the Acquiror’s ownership over the Common Shares will constitute 10% or more of the issued and outstanding Common Shares on an undiluted and partially-diluted basis, and there has been a change of at least 2% since the last early warning report filed by the Acquiror.

The Acquiror acquired 2,233,713 Warrants. Immediately prior to the Transaction, the Acquiror beneficially owned and had control and direction over 6,262,380 Common Shares and warrants exercisable for 50,000 Common Shares, representing approximately 13.57% of the outstanding Common Shares on an undiluted basis and 13.67% on a partially-diluted basis, assuming the exercise of the warrants held by the Acquiror, based upon 46,141,214 Common Shares outstanding prior to the Transaction.

Immediately after the Transaction, the Acquiror beneficially owns, and has control and direction over 6,262,380 Common Shares and warrants exercisable for 2,283,713 Common Shares, representing approximately 13.57% of the outstanding Common Shares on an undiluted basis and 17.66% on a partially-diluted basis, assuming the exercise of the warrants held by the Acquiror, based upon 48,424,927 Common Shares outstanding upon completion of the Transaction.
