The requirement to file this report was triggered as of November 30, 2018 as a result of the decrease in the Eligible Institutional Investor’s holdings of Common Shares of the Issuer to less than 15% of the total Common Shares of the Issuer. See Item 3.1.

EuroPac Gold Fund (the “**Fund**”)

The Fund is an investment fund. Adrian Day, as the Fund’s sub-advisor, is responsible for the day-to-day management of the Fund’s portfolio, selection of the Fund’s portfolio investments, and supervision of its portfolio transactions subject to the general oversight of the Fund’s board of directors and the Fund’s investment advisor.

Adrian Day is eligible to file reports under Part 4 of National Instrument 62-103 in respect of the Issuer.

Since the last report dated July 10, 2018, Adrian Day, on behalf of its asset management clients, acquired an aggregate of 100,100 Shares pursuant to purchases in the public market. Additionally, the Shares held on behalf of asset management clients were decreased by 144,400 Shares pursuant to sales in the public market in the amount of 89,400 Shares and 55,000 Shares due to the closure of accounts. These transactions, in addition to an increase in the number of shares outstanding, resulted in a net decrease in the holdings of Adrian Day, on behalf of its asset management clients, from approximately 15.0% to approximately 14.8% of the issued and outstanding Shares.

As of November 30, 2018, Adrian Day, on behalf of its asset management clients, exercised control over, but did not have ownership of, 9,022,700 Shares, representing approximately 14.8% of the issued and outstanding Shares.
