5.1 Full Description of Material Change

The Company announced that it had closed a non-brokered private placement previously announced on November 16, 2017. It issued 5,940,064 units (“Units”) at \$0.19 per Unit for gross proceeds of \$1,128,612. Each Unit will consist of one common share and one transferrable common share purchase warrant (“Warrant”). Each Warrant will entitle the holder thereof to purchase one additional common share in the capital of the Company at \$0.30 per share for one year from the date of issue, expiring on December 19, 2018. The Warrants are also subject to an accelerator clause. Please refer to the news release dated November 16, 2017 for details.

Finder’s fees of \$29,635 were paid in cash on a portion of the private placement to parties at arm’s length to the Company. In addition, 155,978 non-transferable finder’s warrants were issued (the “Finder’s Warrants”). All other terms and conditions are the same as the private placement warrants.

The proceeds of the financing will be used for exploration programs on the Company’s projects in Argentina and for general working capital.
